## **MEETING MINUTES**

### Review of Minutes from Previous Meeting(s)

Minutes from the Board of Directors meeting of March 15, 2018 were reviewed. A motion was made and seconded to accept the minutes as presented. The motion was passed and the minutes were unanimously approved.

No public comments were received.

## Information and Discussion:

## 1. Current Financial Status

Mr. Lind presented the fiscal year-to-date budget-to-actuals report for the period July 1, 2017 through March 31, 2018. Mr. Lind explained that based on the current report SanGIS projects a surplus of revenues over expenditures of approximately \$65,000 at the end of the fiscal year. This surplus is down from the previous estimate due to additional staff added for special projects – primarily the Local Update of Census Addresses (LUCA) project.

### 2. Other Items

Mr. Lindsay requested and update on the 2017 aerial imagery collection project. The Management Committee reported that the project was complete, all deliverables received, all invoices paid, and all participating funds received.

The Board directed that the May 17, 2018 scheduled meeting be removed from the calendar. The next Board of Directors meeting will be July 19, 2018.

## 3. Request to Approve Contract for Program Management Services

At the March 15, 2018 Board of Directors meeting the Management Committee presented a proposal to contract for program management services through a GSA contract with Corona Environmental Consulting, LLC. The Board reviewed the proposed contract. The key personnel designated in the contract was present at the meeting and answered questions from the Board members regarding background, qualifications, and future vision.

Mr. Lindsay moved that the contract be accepted as proposed including the key personnel designated and that the Board chair be authorized to sign the contract on behalf of SanGIS. Mr. Behnke seconded the motion and the motion was passed unanimously.

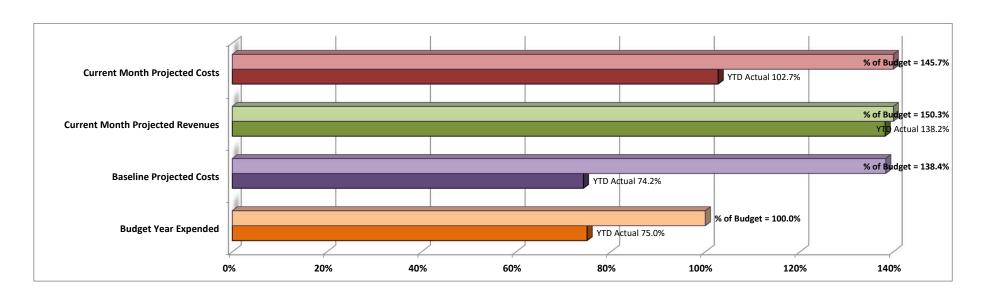
